It is also understood and agreed that the current owner further gives no guarantees, expressed or implied, of the suitability of the horse's temperament to the adopter and the adopter's family. All prior records, history and files for said horse will be given to adopter.				
Horses Make Miracles hereby warrants to vest absolute title and interest of said horse to the Adopter with the understanding that the horse shall not be used in any way compromising his/her health as outlined in this agreement. It is understood that horse (if a mare) will not be bred under any circumstances. Full and legal ownership of said horse is vested in the Adopter and is hereby free from any claims or encumbrances. All parties waive any and all personal liability to each other. I have read and agree to the above terms.
