rehoming fee is non-refundable a	nd must be	paid in fu	ll on or	before	the da	y of
delivery/pickup of Said Horse.						

The Adopter will, at his or her expense, care for Said Horse in a responsible and humane manner. MTH guidelines for care of Said Horse include, but are not limited to: adequate shelter, feed, turnout, worming, farrier, veterinary, and dental care. Any individual or organization in possession of the equine as of the date of the agreement and any time thereafter is bound to not sell the equine at auction for slaughter or allow the equine to be sold, transferred, released, or otherwise placed into possession of any person or organization that will cause or allow the equine to be sold at auction for slaughter.

In the event Adopter fails to adhere to these guidelines and Said Horse becomes neglected or abused in the opinion of an independent professional, this agreement is void, and Said Horse will be immediately returned to MTH at the expense of the Adopter.

All known veterinary records will be provided to Adopter, who understands that Said Horse may need updated vaccinations, worming, dental, and farrier care.

Adopter understands that some conditions of Said Horse are not obvious. The responsibility for determining if Said Horse is fit for use by Adopter belongs solely to Adopter. Adopter acknowledges that Adopter has been advised by MTH to engage the services of a licensed veterinarian and an experienced horse person prior to rehoming to evaluate Said Horse. Adopter agrees to accept Said Horse as is.

Adopter agrees that MTH reserves the right to make scheduled visits and understand that they can return an equine to our organization free of charge.



In the event Adopter decides to sell, assign, or transfer ownership of Said Horse, Adopter will notify MTH in writing of this intent. Upon sale, assignment, or transfer, Adopter will provide MTH in writing with the name, address, and phone number of new owner within 14 days of sale, assignment, or transfer of Said Horse.

Adopter agrees to hereby indemnify and hold MTH and its officers, directors, and volunteers harmless from and against any and all claims, actions, damages, liability, and expense in connection with the loss of life, personal injury, and/or damage to property arising out of use or care of Said Horse.
