PLACEMENT AGREEMENT

IN CONSIDERATION OF THE PLACEMENT OF AN ADOPTED HORSE, THE UNDERSIGNED ADOPTER AGREES TO THE FOLLOWING TERMS AND CONDITIONS CONCERNING THE ADOPTION OF A HORSE THROUGH NORTH WIND RESCUE, CORP.

THE AGREEMENT IS REQUIRED FOR THE ADOPTER TO TAKE PHYSICAL POSSESSION OF THE ADOPTED HORSE WITH NORTH WINDS RESCUE, CORP.

1. NORTH WINDS RESCUE TRACKS EACH OF ITS ADOPTED HORSES FOR ITS LIFETIME. EACH YEAR ADOPTERS ARE REQUIRED TO SUBMIT A 'RESCUED FOR LIFE' FORM. ADOPTERS GIVE A BRIEF UPDATE ON THE HORSE, INCLUDING ITS CURRENT PLACE OF RESIDENCE, ANY INJURIES OR ILLNESSES IT SUFFERED IN THE PAST YEAR, AND ANY TRAINING SUCCESSES ACCOMPLISHED. ADOPTERS ARE ALSO REQUIRED TO SUBMIT AT LEAST TWO (2) CONFIRMATION PHOTOS OF THE HORSE AT THIS TIME, SHOWING EACH SIDE OF THE HORSE. PHOTOS OF HORSE AND ADOPTER ENJOYING THEMSELVES ARE NICE ADDITIONS TO THE STANDARD PHOTOS AND MAY BE SHARED WITH THE ORIGINAL OWNER OF THE HORSE AND/OR SHARED ON OUR WEBSITE OR SOCIAL MEDIA.

2. THE EQUINE MAY NEVER BE RACED. THE ADOPTED EQUINE MAY ALSO NEVER BE SOLD, GIVEN AWAY, OR TRANSFERRED TO ANYONE BUT NORTH WINDS RESCUE DURING THE FIRST FIVE (5) YEARS. NORTH WINDS RESCUE, CORP. RESERVES THE RIGHT TO REFUSE A TRANSFER BACK.

3. SHOULD A LIFE THREATENING SITUATION ARISE IN THE FIRST FIVE (5) YEARS, NORTH WINDS RESCUE, CORP MUST BE NOTIFIED PRIOR TO A DECISION CONCERNING EUTHANIZATION, UNLESS AS A RESULT OF PROFESSIONAL ADVICE AND EMERGENCY WHERE PRIOR NOTICE IS NOT POSSIBLE. EUTHANIZATION IS **NOT** THE ADOPTER'S CHOICE.

A CERTIFICATE OF DEATH MUST BE RECEIVED FROM A LICENSED VETERINARIAN FOR ALL DECEASED EQUINES WITHIN 10 DAYS OF THE EQUINE'S DEATH.

4. ONCE AN ADOPTION IS ARRANGED, TRANSPORTATION COSTS ARE THE RESPONSIBILITY OF THE ADOPTER.

5. ADOPTERS ARE PERMITTED TO SELL THEIR ADOPTED HORSE AFTER THE FIRST FIVE (5) YEARS. HOWEVER, ALL ADOPTERS FIRST MUST NOTIFY NORTH WINDS RESCUE OF THEIR INTENTION TO SELL, GIVING NORTH WINDS RESCUE FIRST RIGHT OF REFUSAL. IF NORTH WINDS RESCUE PASSES, THE SUBSEQUENT PURCHASERS OF THE HORSE MUST SIGN A TRANSFER AGREEMENT WITH NORTH WINDS RESCUE. THIS FORM MUST BE COMPLETED **PRIOR** TO THE NEW OWNER TAKING OWNERSHIP OF THE HORSE IN QUESTION. THE NEW OWNER WILL BECOME RESPONSIBLE FOR YEARLY SAVED FOR LIFE UPDATES. IN THIS WAY, NORTH WINDS RESCUE WILL CONTINUE TO TRACK AND MONITOR ITS HORSES WITH UPDATES EVERY YEAR FOR THE REST OF EACH HORSE'S LIFE. ANY INDIVIDUAL OR ORGANIZATION IN POSSESSION OF THE EQUINE AS OF THE DATE OF THE AGREEMENT AND ANY TIME THEREAFTER IS BOUND TO NOT SELL THE EQUINE AT AUCTION FOR SLAUGHTER OR ALLOW THE EQUINE TO BE SOLD, TRANSFERRED, RELEASED, OR OTHERWISE PLACED IN POSSESSION *OF ANY PERSON OR ORGANIZATION THAT WILL ALLOW THE EQUINE TO BE SOLD AT AUCTION FOR SLAUGHTER.*

6. REQUIRED WEIGHT: NAMED EQUINE MUST MAINTAIN WEIGHT AND CONDITION AS ADVISED BY A LICENSED VETERINARIAN.

7. ADOPTER AGREES TO PROVIDE PROPER FEEDING TO MAINTAIN PROPER WEIGHT, FREE ACCESS TO CLEAN WATER, A MINIMUM OF A 3 SIDED SHELTER, AND ADEQUATE FENCING.

8. ADOPTER AGREES TO PROVIDE THE FOLLOWING VETERINARIAN CARE:

a. WORMING EVERY MINIMUM OF EVERY 12 WEEKS

b. HOOF CARE EVERY MINIMUM OF EVERY 8 WEEKS

c. DENTAL CHECK MINIMUM OF ONCE A YEAR

d. MAR/APR SPRING INOCULATION: FLU, RHINO, DENTAL, TETANUS, RABIES, WEST NILE

e. SEP/OCT FALL INOCULATION: FLU, RHINO, AND STRANGLES

f. INOCULATIONS MUST BE ADMINISTERED BY A LICENSED VETERINARIAN FOR THE FIRST FULL YEAR AFTER ADOPTION. IF YOU CHOOSE TO VACCINATE YOUR OWN EQUINE AFTER THIS TIME, PLEASE STATE WHICH VACCINATIONS YOU WILL ADMINISTER AND HOW OFTEN.

13. IF YOU WISH TO RETURN YOUR ADOPTED EQUINE TO NORTH WINDS RESCUE, CORP, TRANSPORTATION COSTS AND ANY AND ALL COSTS REQUIRED TO SAFELY TRANSFER THE HORSE BACK TO THE NORTH WINDS RESCUE, CORP ARE THE RESPONSIBILITY OF THE ADOPTER. NORTH WINDS RESCUE, CORP RESERVES THE RIGHT TO REJECT THE TRANSFER BACK OF ANY EQUINE. ALL RETURNED EQUINES MUST HAVE A CURRENT YEAR COGGINS TEST. FAILURE TO PROVIDE THIS IS CAUSE FOR REFUSAL OF THE EQUINE, A \$100 CHARGE, OR BOTH. WHICHEVER IS APPROPRIATE FOR THE SITUATION.

14. NO WARRANTIES. THE ADOPTED EQUINE IS TRANSFERRED TO ADOPTER UNDER THIS AGREEMENT AS IS, WITHOUT GUARANTEE OR WARRANTY OF ANY KIND, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

15. THE ADOPTER AGREES TO ASSUME ALL RESPONSIBILITY FOR ALL COSTS AND EXPENSES RELATED TO THE CARE, FEEDING, AND MAINTENANCE OF THE ADOPTED EQUINE AS WELL AS NECESSARY TO COMPLY WITH ADOPTER'S RESPONSIBILITIES SET FORTH IN THE PLACEMENT AGREEMENT.

16. THE ADOPTER AGREES NOT TO ALLOW A LIEN OR SECURITY INTEREST TO BE PLACED ON ANY ADOPTED HORSE.

17. RELEASE AND INDEMNIFICATION. ADOPTER FOR HIMSELF OR HERSELF, HIS OR HER HEIRS, PERSONAL REPRESENTATIVES, SUCCESSORS AND ASSIGNS, FULLY AND FOREVER WAIVE RELEASE AND DISCHARGE NORTH WINDS RESCUE, CORP, ITS OFFICERS, AGENTS, EMPLOYEES, AND ALL PRIOR OWNERS OF THE ADOPTED EQUINE FROM ANY AND ALL CLAIMS, DEMANDS, ACTIONS, CAUSES OF ACTION RESULTING FROM OR ARISING OUT OF, OR RELATED TO THE POSSESSION, CARE, MAINTENANCE OR ACTIONS OF THE EQUINE ADOPTED UNDER THE AGREEMENT. ADOPTER FURTHER AGREES TO INDEMNIFY AND HOLD HARMLESS NORTH WINDS RESCUE, CORP. ITS OFFICERS, AGENTS, EMPLOYEES, AND ALL PRIOR OWNERS OF THE ADOPTED EQUINE FROM ANY AND ALL CLAIMS WHICH MAY BE ASSERTED BY OTHER PARTIES RESULTING FROM, ARISING OUT OF, OR RELATED TO THE POSSESSION, CARE, MAINTENANCE OR ACTIONS OF THE EQUINE ADOPTED.

19. NORTH WINDS RESCUE, CORP. SHALL HAVE THE RIGHT TO RECOVER THE POSSESSION OF THE ADOPTED EQUINE IF WITHIN IT'S SOLE DISCRETION DETERMINES THE HEALTH OF THE ADOPTED EQUINE IS ADVERSELY AFFECTED BY THE CONDITION OF IT'S ENVIRONMENT, OR IN THE EVENT THE ADOPTER FAILS TO EXERCISE HIS/HER RESPONSIBILITIES OR OTHERWISE COMPLY WITH THE TERMS OF THIS AGREEMENT.

20. ADOPTER HEREBY AGREES TO PAY ALL NECESSARY AND REASONABLE COSTS INCURRED BY NORTH WINDS RESCUE, CORP. IN RECOVERING THE POSSESSION OF THE ADOPTED EQUINE UNDER PARAGRAPH 20 HEREIN, INCLUDING ALL COSTS AND ATTORNEY'S FEES NECESSARY TO ENFORCE NORTH WINDS RESCUE, CORP'S RIGHT UNDER THIS AGREEMENT.
