ADOPTER

Upon transfer of possession of the Equine, the Adopter assumes all risk of loss or injury to Equine. Adopter hereby agrees to assume any and all risks of injury, death or property damage whether those risks are known or unknown. Adopter agrees to forever release Possessor, its officers, directors, employees, agents, volunteers, successors, predecessors, transferees, assigns, attorneys, insurers and/or personal representatives, from any and all actions, claims or demands that Adopter, Adopter's heirs, distributes, guardians, next of kin, spouse or legal representatives now have, or may in the future, for injury, illness, death or property damage related to said Equine / Agreement.

Equine shall, at all times, have a clean, safe shelter from inclement weather (extreme temperatures, wind, heavy rain, storms, etc.), and be kept at a location where other equines reside, sufficient high quality forage, supplemental feed (when needed), free choice water and mineral access, vaccinations, safe fence and pasture (nothing loose, exposed, sharp etc.), and sufficient room for exercise. Adopter shall always have an equine dentist, veterinarian, and farrier made available to the Equine when needed.

Equine shall not be hit, beaten, or abused. Adopter shall treat Equine with kindness at all times. Adopter shall not maliciously or negligently injure the Equine. Adopter shall provide a copy of this Agreement to any boarding facility and or trainer Adopter uses.

The Adopter agrees not to breed the purchased Equine. If the Equine is a female, the Adopter agrees not to keep the Equine in proximity to a stud or non-gelded equine, either by accident or purposefully. Mares will not be transferred to an Adopter whose facility has a stud or non-gelded equine residence. Any and all male equines are gelded prior to arrival to Ride On St. Louis, Inc.

Adopter and or any individual or organization in possession of the Equine as of the date of the agreement and any time thereafter is bound to not sell the Equine at auction for slaughter or allow the equine to be sold, transferred, released, or otherwise placed into possession of any person or organization that will cause or allow the equine to be sold at auction for slaughter.

Adopter agrees that if Adopter ever chooses to sell, transfer or giveaway the Equine they will give Possessor the first right of refusal to re-possess the Equine to be negotiated between both parties. Should the Adopter decide to re-home the Equine, the Possessor must grant approval of any individual or organization intending to take possession of the Equine for any

reason prior to the Equine being placed into the possession of such individual or organization, including being provided written notification of the name, address, and telephone number of any individual or organization intending to take possession of the equine for any reason.

This Agreement shall remain in effect until the death of the Equine. The terms of this Agreement are binding on any future adopter or any third-party person or entity taking possession of the Equine and this Agreement must be incorporated as an addendum to any future agreement. Any future adopter or any third-party person or entity taking possession of the equine must re-sign an agreement with the Possessor prior to the Equine being placed into the possession of any future adopter or any third-party person or entity.

Possessor reserves the right to make scheduled visits.

This Agreement is agreed to in full by Adopter and Possessor.
