The White Bird Appaloosa Horse Rescue Rescues, Rehabilitates and Rehomes at risk Appaloosa and other horses. Horses that cannot be adopted are provided permanent sanctuary. The rescue provides community support to those families unable to continue caring for their horses, interacts with local Animal Control officers, and conducts outreach and educational sessions.

Equine Rehabilitation: Feed and Hay, plus supplements for approximately 30 horses. Feed and hay continue to be a large cost item. During 2017 the cost of hay and feed used has increased and more hay was purchased from suppliers.

4b (Code:) (Expenses \$ 17,644 including grants of \$ 17,644) (Revenue \$ 0)

Equine Rehabilitation: Includes veterinary care, farrier work, medical supplementation and health care items. Rescues arrive in a variety of conditions - starved, unsound, and with a range of medical problems. Again this year the rescue continues to rehabilitate the unhandled horses, as well as taking in new horses from a variety of sources. The small decrease in funding for this service over 2016 reflects a slight change in the average number of rescued horses, during the year. The total includes rehabilitative care and end of life euthanasia when necessary.

4c (Code:) (Expenses \$ 34,468 including grants of \$ 34,468) (Revenue \$ 0)

Equine Housing: While the rescue's facilities and foster homes are donated space, horses are large, strong animals that are rough on infrastructure such as shelters and fences. The repair and upkeep of facilities and equipment to keep them usable and safe is an ongoing expense. The large increase in this service cost reflects continuing maintenance, repair and additions to old facilities, plus the purchase of new facilities, as well as rising costs of materials and equipment.
