

## Adoption Agreement

THIS ADOPTION AGREEMENT CONTRACT ("Adoption contract") entered into by and between ENDEAVOR THERAPEUTIC HORSEMANSHIP, INC. ("Endeavor") and \_\_\_\_\_ (the "Adopter") for the rehoming/adoption of one hundred percent (100%) of \_\_\_\_\_ (the "Horse").

WHEREAS, the Endeavor owns one hundred percent (100%) of the Horse, and Endeavor has agreed to rehome one hundred percent (100%) of the Horse to Adopter.

### WITNESSETH:

Endeavor hereby warrants and represents that he has good and marketable title on the Horse; is the sole lawful owner of the Horse; has the right to sell the same as herein done; and that this Horse is free and clear of all liens and encumbrances of whatsoever kind and nature. This Bill of Sale shall inure to the benefit of the Adopter's and Endeavor's respective successors, assigns and transferees.

Adopter hereby agrees and understand that should they sell the equine sell, transfer, release, or otherwise place the equine into possession of any other person or organization they will include in the transfer of ownership agreement that the new owner will not sell the equine at auction for slaughter or allow the equine to be sold, transferred, released, or otherwise placed into possession of any person or organization that will cause or allow the equine to be sold at auction for slaughter. As well as that any further transfer of ownership will include this statement as well.

Adopter hereby agrees and understand that they are bound to not sell the equine at auction for slaughter or allow the equine to be sold, transferred, released, or otherwise placed into possession of any person or organization that will cause or allow the equine to be sold at auction for slaughter

Adopter hereby agrees that should they rehome, or sell the horse they will first notify Endeavor with the name, address, and telephone number of any individual or organization intending to take possession of the equine for any reason prior to the equine being placed into the possession of such individual or organization.

Endeavor hereby reserves the right to make scheduled visits to see the horse.

Endeavor hereby agrees that adopter can return horse free of charge, with notice.

Adopter hereby agrees to provide yearly updates including photos and vet records for the next five years

Except as to title, this Horse is sold "AS IS" without warranty.

1- Should the adopter decide to re-home the equine, the organization must grant approval of any individual or organization intending to take possession of the equine for any reason prior to the equine being placed into the possession of such individual or organization, including being provided written notification of the name, address, and telephone number of any individual or organization intending to take possession of the equine for any reason .

This agreement shall remain in effect until the death of the equine. The terms of this agreement are binding on any future adopter or any third-party person or entity taking possession of the equine and this agreement must be incorporated as an addendum to any future agreement.

2- Should the adopter decide to re-home the equine, the organization must grant approval of any individual or organization intending to take possession of the equine for any reason prior to the equine being placed into the possession of such individual or organization, including being provided written notification of the name, address, and telephone number of any individual or organization intending to take possession of the equine for any reason .

This agreement shall remain in effect until the death of the equine. The terms of the agreement are binding on any future adopter or any third-party person or entity taking possession of the equine. Any future agreement must require any future adopter or any third-party person or entity taking possession of the equine to re-sign an agreement with the organization prior to the equine being placed into the possession of any future adopter or any third-party person or entity.

This Adoption Contract be governed by and construed under the laws of the State of New York.
