**NO SLAUGHTER/NO AUCTION**

The undersigned agrees that this animal will only be transferred privately and will not be resold at any type of auction, to a known horse broker, feed lot or slaughter destination. In the event the undersigned fails to comply with the terms of this Application and Agreement, \_\_\_\_\_ (Runnin Free Ranch) reserves the right to commence legal proceedings to recover the horse, and the undersigned shall be liable for all costs including damages, inclusive of attorney's fees, in connection with such legal proceeding.

**RUNNIN FREE RANCH'S REPRESENTATIONS AND WARRANTIES**

Runnin Free Ranch makes no warranties whether expressed or implied, including but not limited to, any implied

warranty of merchantability or fitness for a particular purpose. The adoption of the horse is subject to the terms and conditions of an "as is" ADOPTION. It is further noted that Runnin Free Ranch is the sole owner of horse and has authority to enter into this Agreement. There is no lien or encumbrance on the horse. Runnin Free Ranch shall provide adopter with horse's registration papers, if any, and all other documents necessary to transfer registration of the horse from Runnin Free Ranch to the adopter after one of possession of horse.
