From the date hereof the adopter agrees to be responsible for the safety, security, welfare and wellbeing of the horse and provide care in a humane and responsible manner. Adopter agrees to provide him/her with clean and adequate shelter, a safe enclosed area, food, water and veterinary care. Horses Make Miracles reserves the right of access for a home visit to adopter's property prior to permanent rehoming.

The adopter understands and agrees that Horses Make Miracles makes no representations or warranties, expressed or implied, about the horse's temperament and is hereby absolved from any liability for future damages or injuries caused by said horse. It is also understood and agreed that the current owner further gives no guarantees, expressed or implied, of the suitability of the horse's temperament to the adopter and the adopter's family. All prior records, history and files for said horse will be given to adopter.

Horses Make Miracles hereby warrants to vest absolute title and interest of said horse to the Adopter with the understanding that the horse shall not be used in any way compromising his/her health as outlined in this agreement. It is understood that horse (if a mare) will not be bred under any circumstances. Full and legal ownership of said horse is vested in the Adopter and is hereby free from any claims or encumbrances. All parties waive any and all personal liability to each other. I have read and agree to the above terms.

I certify that all statements made by me on this rehoming agreement are true and correct. I agree that the current owner (Horses Make Miracles) has the right to confiscate the above described horse in the event that any statements made by me are found to be false.
