**Please read the following carefully. By signing this document, you may be giving up rights that you might otherwise have. This document transfers ownership of stated horse, free and clear of any liens.**

I will have a veterinarian examine the horse once each year and follow any recommendations the veterinarian feels are necessary. I will be solely responsible for this examination. I will direct the examining veterinarian to send written notice of findings within 7 days of completion of examination to Hasty's Haven Inc. 1228 Christopher Ln Liberty, SC 29657. If this offer is accepted by Hasty's Haven Inc., I agree that said animal shall reside with the minimal corral space of three hundred (300) square feet, with sanitary living conditions, constructed of wood or pipe, with shelter from the elements and will be provided with inoculations as recommended by Hasty's Haven Inc. I understand and agree that said animal may not be sold, given away, lent, leased, sold for slaughter, removed from my personal supervision or moved from the address described herein without Hasty's Haven Inc. prior approval and that if I am proved in violation of any of the above, I shall be subject to legal action. I agree that the horse will not be neglected or abused. The body score will be based on a Hennecke Score. Should the horse, for any reason, begin losing weight, Hasty's Haven Inc. will be contacted immediately. If upon inspection, the horse is discovered to be 3.5 to 3.0 adopter will be given 30 days and reevaluated. If the body score is a 2.5 or less at that time and Hasty's Haven Inc. has not been notified, the horse will be seized. If for any reason there is any suspicion that all conditions of this agreement are not complied with, I agree that an authorized representative of Hasty's Haven Inc. may enter the property where the animal resides. I further agree to accept all responsibility for any action or lien resulting from any action, directly or indirectly involving said animal while it is in my care. Therefore, I agree and understand that neither Hasty's Haven Inc. nor its employees or agents will be liable for any damages or injury caused to me or any third person by the animal once I receive delivery of it, including but not limited to damages or injuries caused by the fact that the animal does not behave or perform in the manner I expected. Further, if any third person makes a claim against Hasty's Haven Inc. or any of its employees or agents as a result of any conduct of the animal after I have taken possession of it, I agree to indemnify and hold Hasty's Haven Inc., its employees and agents harmless from any such claim, including costs and attorney's fees resulting from such claim. I will be responsible for returning the horse to Hasty's Haven Inc. or I will pay all costs involved in their return by an authorized representative Hasty's Haven Inc. if I am unable to care for the animal, or if I am found in default of any of the conditions of this

agreement. In the event of my death during this agreement, I direct that funds from my estate be used to return the horse herein described to Hasty's Haven Inc. If the animal is determined, by a veterinarian, to be in debilitated or unhealthy condition on return, I will be responsible for all costs incurred to return the animal to healthy condition. In the event the undersigned fails to comply with the terms of this Application and Agreement, Hasty's Haven Inc. reserves the right to commence legal

proceedings to recover the horse, and the undersigned shall be liable for all costs, inclusive of attorney's fees, in connection with such legal proceeding.

This document transfers the ownership of the horse with stipulation of care. All horses adopted through Hasty's Haven Inc. have a no breeding and no racing policy. When adopting from Hasty's Haven Inc. we require an update every quarter minimally. There may be visits or checks by the local animal agency as well as Hasty's Haven Inc. if a complaint is made.
