WE DO NOT HAVE PASTURE, SO WE FEED AND GRAIN OUR HORSES YEAR-ROUND, WITH FEED COST ALONE TOTALING \$179,480 THIS YEAR AND VETERINARY COST AT \$63,124. THE INCREASE IN OUR ONSITE HORSE CAPACITY TO 100, AS WELL AS RISING PRICES AND WAGES, HAVE ALSO INCREASED ALL OTHER REHABILITATION AND CARE-RELATED EXPENSES, SUCH AS RANCH PAYROLL, VETERINARY AND DENTAL CARE, FARRIER, WORMING, AND VACCINATIONS. WE UTILIZE A SPONSORSHIP PROGRAM TO HELP SUPPORT OUR HORSE CARE EXPENSES AND WERE ABLE TO RAISE \$131,599 IN 2024 THANKS TO 76 SPONSORS, SUPPORTING 78 OF OUR HORSES.

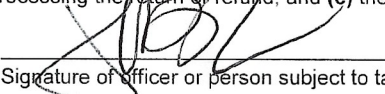

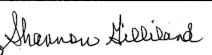
