About Sabu

Sabu, a 24 year old Thoroughbred, is the first to greet the inner-city kids when the bus from the detention center pulls in the driveway at EQUUS Foundation Mentor Brook Hill Farm. As a rescue, Sabu had to overcome starvation and abuse, with his background just as painful as their own. He directly identifies with the teens he works with. He makes them feel safe, helps them to identify their emotional trauma, develop resilience, and, with the help of the staff, find healthy coping strategies in a new and experiential way.

About Bear

Bear is one of the most popular and reliable horses in the Special Equestrians herd. Registered as Wagontrain MHH, this special Haflinger was inducted into EQUUS Foundation's Horse Stars Hall of Fame in 2024. For more than two decades, Bear has played a critical role in every program Special Equestrians offers and touched the lives of thousands of individuals with cerebral palsy, Autism Spectrum Disorder, brain injury, PTSD and more. Bear has also worked with 25 community partners over the years, including area schools and nursing homes. All told, this dependable workhorse has participated in over 10,000 lessonsl





About Ruby

After the death of their young owner seven years ago, an 11-yearold registered Belgian mare named Fezziwig Tulip and her sire, Fezziwig Pom Parkins (known as Ruby and Pom, respectively) were left in the care of her parents; soon, the financial burden became overwhelming, and difficult decisions had to be made. Fortunately, both animals were taken in by EQUUS Foundation Mentor Lucky Orphans Horse Rescue, which provides both lifetime sanctuary to horses at risk and equine experiential learning and outreach opportunities to individuals, groups, and organizations.



About Chester

Chester was seized by a sheriff department in Texas when they learned he had been tied to a tree from the time he was a 2-year-old. Kelly Saunders, Executive Director, Bagaduce River Equine Rescue, found him in 2018 when he was 6 at the Kauffman Kill pen. Kelly said, "I had to shove everything I had ever learned about horses' way down deep and open my eyes, my brain and my heart to this little Arabian gelding that will never leave our rescue or my heart. Chester is going blind from an autoimmune disorder. His body will never carry a human because of his confirmation and deformities. The malnutrition and lack of movement he suffered as a colt caused Chesters body to never develop the way it should have. But, today Chester moves with grace and elegance. When he lets his body take over and doesn't think about it, the blood of his Arabian ancestors flowing through his body takes over and he could be sailing across the desert, his hooves barely touching the ground. Now he knows how to be a horse and now he is home. Chester is my mentor, my hero and my friend."

President's Letter

From the very start 23 years ago, the EQUUS Foundation was established to not only recognize all that horses have done for us for centuries, in work and in war, and all that they continue to do for us as athletes, companions, healers and teachers but also that many thousands of America's horses become at risk for neglect, abuse, and the slaughter pipeline each year simply because they fall through the cracks when transitioning from one owner or one job to another.

We have seen progress.

- The number of equines being transported across our borders for slaughter is at an all-time low compared to the peak of 166,572 in 2012.
- With more equine charities focused on retraining and re-homing, there has been positive change in the perception of the "rescue" horse as not just vulnerable but also viable making adoption more appealing.
- The number of organizations focused on providing services to humans that incorporate horses is increasing, giving more horses in transition the opportunity for multiple careers.

We are proud to share our 2024 Annual Report and our accomplishments and thank the many individuals and organizations who helped make 2024 a great success.

But the world gets more complicated with each passing day — with many different opinions and beliefs. For the EQUUS Foundation, the lingering resistance within the equine community to accept that we owe horses lives worth living from beginning to end represents a major obstacle and could set back the gains we have made.

Our commitment to the horses we love and to those whose lives are elevated by horses remains steadfast. We must accept that public trust in how horses interact with people is critical to ensuring a promising future and we must put an end to the slaughter pipeline.

Bottom line: We must accept responsibility for our actions and refrain from actions that jeopardize the welfare of horses. The welfare of America's horses is in our hands and the time to rally together is now.






