## President's Message

The EQUUS Foundation was founded in 2002 following a deeply personal experience—my search for a safe and humane retirement for my daughter's show horse. That journey revealed a fragmented equine welfare landscape, one in which horses in transition were often vulnerable to neglect, abuse, or the slaughter pipeline, and where donors lacked reliable ways to identify responsible, high-quality organizations worthy of their support.

It became clear that protecting horses required more than rescue alone. It required standards, education, leadership, and a sustained commitment to long-term organizational and operational excellence. Just as importantly, it required a community of informed, engaged supporters willing to stand with organizations doing the hard, often unseen work of caring for horses over a lifetime.

More than two decades later, the EQUUS Foundation has grown into a robust national charity dedicated to ensuring that America's horses can continue to partner with people as companions, teachers, and healers long after their sport careers have ended. Our work empowers equine charities to operate with transparency and at the highest standards of horse care; inspires horse lovers to become horse protectors through advocacy, volunteerism, and meaningful engagement; and educates the public about our shared responsibility to the horses we love and the profound ways in which horses enrich human lives.

We advance this mission by cultivating strong partnerships with individuals and equine organizations nationwide and by facilitating innovative collaborations that connect horses and people through both Equine Transition Services and Equine Assisted Services. As you will see in this Annual Report, This year alone, with the support of our donors and partners, the EQUUS Foundation helped strengthen the care and futures of 4,200 equines horses through support of 139 organizations across the country. These outcomes are not accidental—they are the direct result of sustained investment in quality, accountability, and capacity-building across the equine welfare sector.

Yet the need remains significant. As more horses exit competitive careers and more communities seek the healing power of horse-human connections, the demand for safe, ethical, and financially sustainable equine organizations continues to grow. Meeting that demand—and protecting horses at every stage of life—depends on continued philanthropic support and engaged leadership from those who believe horses deserve nothing less than excellence.

Our commitment—to horses, to the people they serve, and to the organizations that protect them—remains steadfast. Together, we are strengthening the future of equine welfare and ensuring that horses are honored, protected, and valued throughout every stage of their lives.

With sincere gratitude to all who have supported, encouraged, and contributed to this work, I am proud of what the EQUUS Foundation has accomplished and deeply inspired by what lies ahead. Thank you for being part of this journey. Your continued support—through giving, advocacy, and engagement—makes it possible to protect America's horses today and for generations to come.

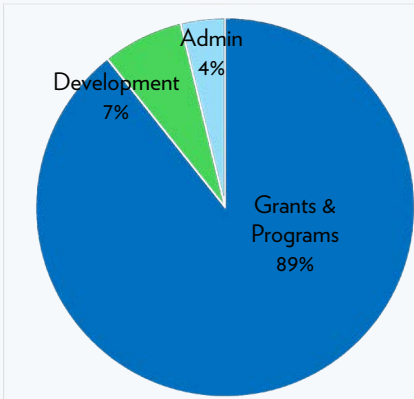

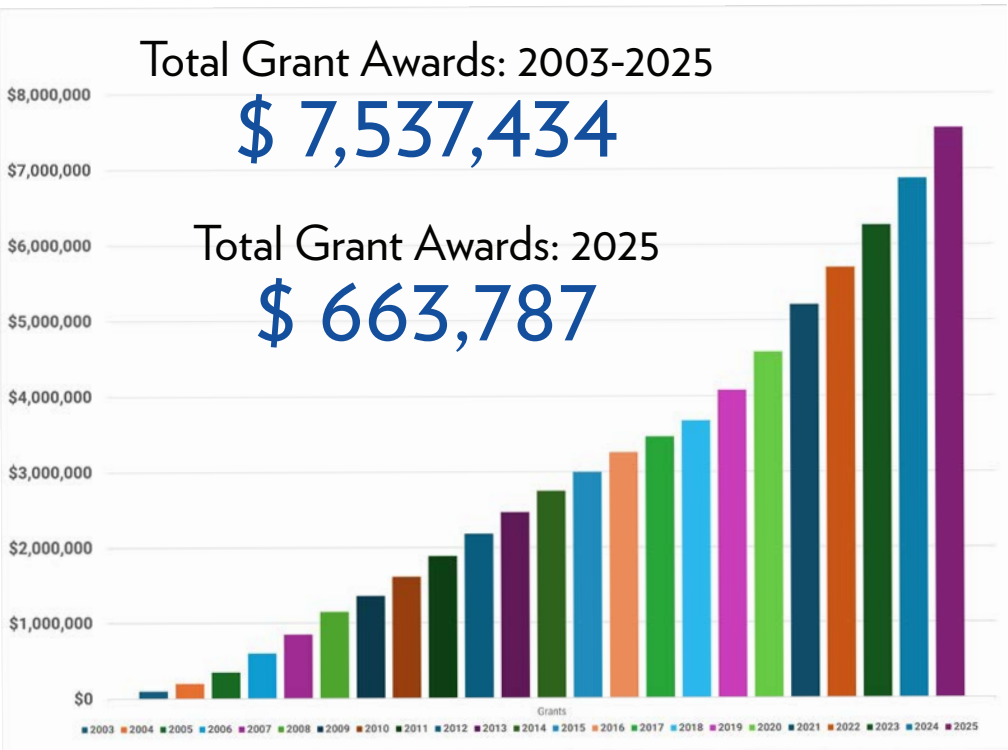

All submissions are evaluated for accuracy and consistency, cross-checked against prior filings and public records, and verified through direct communication with each organization. Equine health and wellness practices are independently confirmed through correspondence with attending veterinarians.

Best practice areas are evaluated in equine care; equine census and residency, including intake, length of stay, outcomes and including mechanisms for lifetime-care traceability; governance and organizational policies; and financial practices and sustainability.

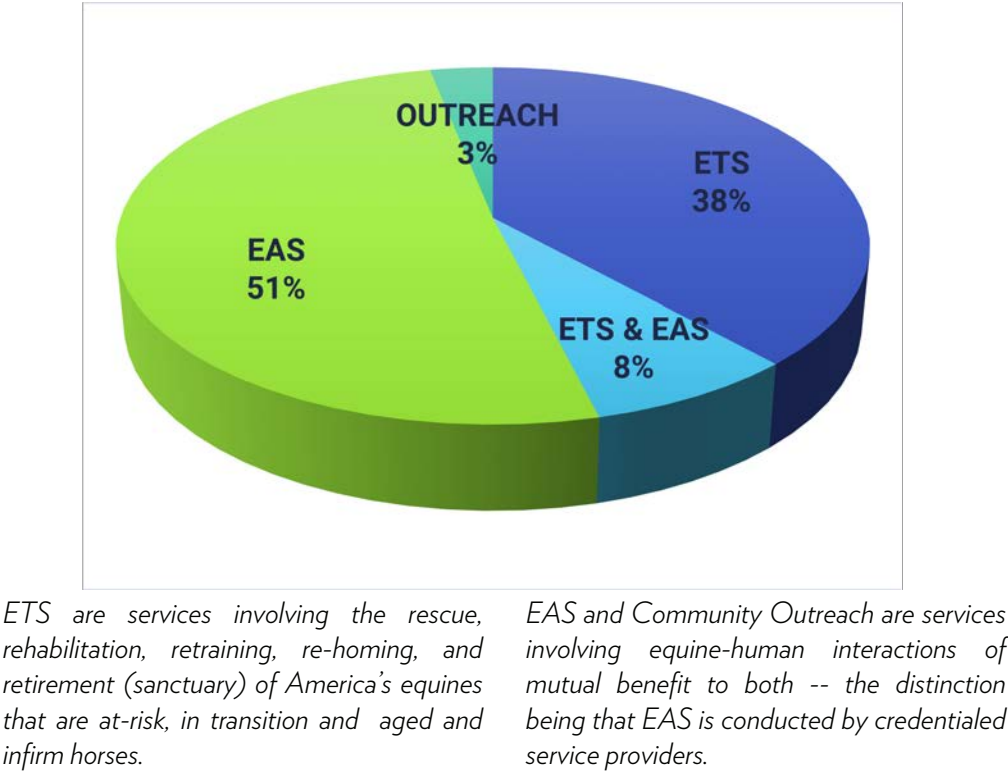

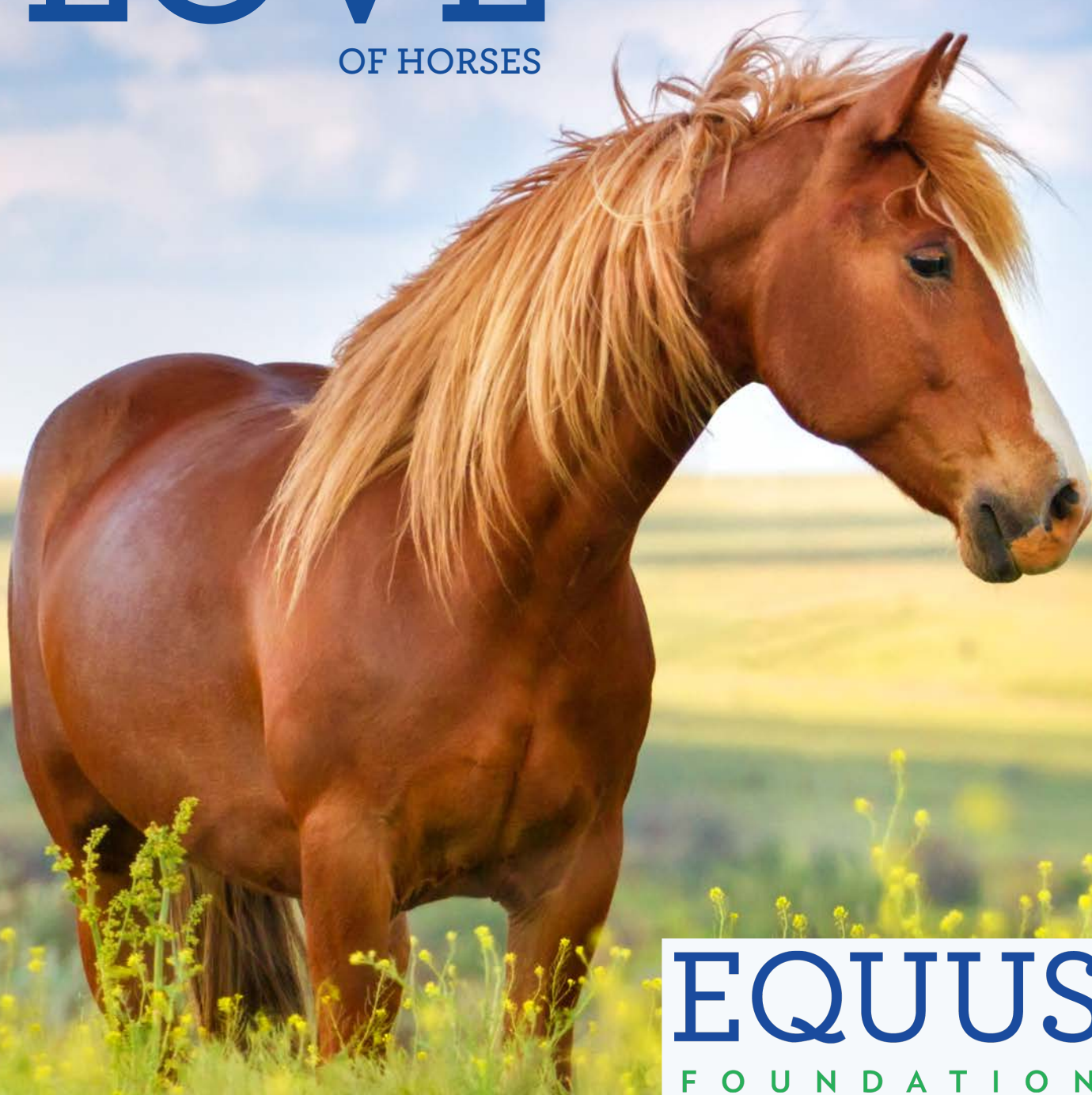
